1. Apologies for absence were received by Councillors Glyn Haynes, Raymond Jones, Vaughan Williams, Ann Kennedy and Trefor Lloyd Hughes MBE

2. **DECLARATION OF INTEREST:**  
No declarations were made.

3. Daniel Williams thanked the Town Council for an opportunity of saying a few words. He had been involved in the construction of skate-parks in Asia and locally. A temporary skate-park had been constructed near to the old Postal Sorting office but this land was now being used by Home Bargains for a new store.

Daniel had met with Iain Young from "Concrete Skate parks" and the Town Clerk when they made a site visit to the Holyhead Town Park. "Concrete Skate parks" had provided a written Quote for a total figure of £45,000.00 to the Holyhead Town Council and this Company were willing to commence the construction of the skate-park as from Monday 29 October 2018 once they had been given the go ahead from the Town Council to accept the Quote. Daniel stated that the proposed skate-park would be used by all ages from children to adults and they would be taught how to respect others in using the equipment and it would be beneficial for them in exercise and being in the fresh air.

The most suitable site would be near to the BMX track.

*It was resolved, proposed and seconded that the Holyhead Town Council accepts the Quote from "Concrete Skate parks" and request that the Company commence the works as from the 29<sup>th</sup> October 2018. (Proposed in the Communities/Leisure Sub-Committee meeting held on 17 October 2018).*

Once the new skate-park was in operation the Mayor would arrange an official opening, with the local press being informed.

Robert Henderson, Community Services Manager would put on Facebook the news of the construction of the new skate park.

4. **CRAZY GOLF COURSE:**

The Town Clerk confirmed that he had recently met with officers of the Anglesey County Council Economic Development Unit and they had informed him that there were funds possibly available that would be available towards a new crazy golf course. The Town Clerk had received a Quote from "Urban Crazy" in the sum of £41,000.00 + VAT for a 18 hole crazy golf course which was the cheapest quote and the most suitable location for this would be on the 2<sup>nd</sup> bowling green which would be in an enclosed space and suitable under health & safety regulations.

*It was resolved, proposed and seconded that the Town Council proceed with the crazy golf course if the funding from the Anglesey County Council has been received.*
