1. To ask the question, Any Councillor or Member making a recording of this meeting?

Yes, Alex Williams is taking minutes of the meeting.

2. Apologies of absence were received from Cllr Beryl Warner BEM, Cllr Vaughan Williams.

3. Declaration of interest was made by Cllr Hywel Williams and Cllr Trefor Lloyd Hughes MBE regarding item 7 on the Agenda.

4. The Council were informed of updates and developments since the previous meeting where Ian Davies and Ed Lavelle attended and stressed that they are currently aiming towards finishing business plans and submitting them before the next general election. The current time frame is August to have the plans submitted to the Welsh and UK Government.

Questions were asked regarding the former Tinto Chimney and the new date for it to be demolished. There was no confirmed date as of yet.

5. Minutes of the previous meetings were proposed, first and seconded to be of true record.

6. Mayors Announcements – Cllr Hywel Williams informed the Council of previous meetings in which he had attended along with welcoming and joining in with the St Davids day parade which was cancelled and held at the Town Hall.

7. Llanfawr Road –

Cllr Hywel Williams Declared an interest in this item and left the Chamber. Cllr Richard Parry sat as chair for the item.

A member of public was given three minutes to speak in which he discussed the protection of Green Spaces and the previous planning application which was made for Llanfawr Road in 2014. He informed the Council that it is imperative to remind the planning committee that natural locations such as Llanfawr Road is protected as it improves quality of life and serves and enhances habitats.

Cllr Parry thanked Mr Jones for his statement and presented his case well to the Council. The Town Clerk informed the council that they would need to discuss a way forward to which they proposed, first and seconded that he would be given the opportunity to discuss the next steps with the Architect regarding the pre-planning application for Llanfawr Road. The Council will be informed of any updates in the coming months and stressed that this would be something that takes months to conclude.

Cllr Howard Browes abstained from taking a vote regarding the planning consultation.

8. Internal Audit Report was deferred from this meeting until all relevant documentation is available to the Council.
