2. Apologies of Absence were received from Cllr Beryl Warner BEM, Cllr Ailia Lewis MBE, Cllr Adrienne Edwards, Cllr Susan McGinn, Cllr Cadi Evanson, Cllr Trefor Lloyd Hughes MBE, Cllr Vaughan Williams.

3. Declaration of interest was made by Cllr Glyn Haynes. Minute No. 5081/2024

4. Presentation from Ed Lavell and Ian Davies was rescheduled for the month of March. Minute No.5082/2024

5. Cae Rhos FPL/2023/353

It was proposed, first and seconded that Holyhead Town Council object to the planning consultation listed in the Agenda on the grounds of poor traffic management. Minute No. 5083/2024

6. Motion to exclude public from meeting

Proposed, first and seconded that public attending the meeting are to be excused. Minutwe No. 5084/2024

7. the minutes of the previous Staffing committee meeting were given out to Councillors. The Town Clerk stressed that any information which is included in the minutes are completely confidential and should not be spoken about outside of the Council Chamber. The minutes of the previous meeting were proposed, first and seconded to be of true record. Minute no.5085/2024

8. 9 Monthly Reports

Cllr Parry explained the income and expenditure and projected this to 12 months comparing it to the 2023/24 budget.

The increase is attributed to an increase in staff costs above the 3% in the budget and other factors. The process of the 9 monthly report is to show actual figures of the council's income and expenditure against the previous budget. The 9 monthly reports were proposed, first and accepted. Minute no. 5086/2024

9. Budget 2024/25

The Budget was explained by Cllr Parry highlighting increases and decreases e.g. bus stop refurbishment reduction in donations and the effect of the empire closure for 4 months.

The Town Council is responsible for seven eighths of the Burial Board, and it sees a lower precept set for the financial year than in the previous due to staff costs reducing.

the Budget for the Christmas lights has been significantly reduced due to having purchased new lights in the 2023/24 budget.

The budget for the allotments remains the same as there is no financial costs towards to upkeep and the opening of the newly formed Empire Complex should begin to see a increase in income once the LUF project has been completed due to having the extra capacity to hold private functions without the need to close.

It was proposed, first and seconded to accept the recommendation from the Finance and Property committee to accept the Budget for the 2024/25 financial year which will see an increase of £3.17 Per Week on a Band D Property compared to last year's stand still budget. Minute no. 5087/2024
